- System updates: NDOT is currently putting together an RFP for a routing and permitting system. We expect this to be out in early 2018. I am hopeful our system will be up and running by next year's meeting.
- Procedural changes: We have encouraged our customer base to use the online system, this has increase our online usage of more than 50%
- Special Initiatives: Nevada has two RFP's currently out. The first one is put in place to help the state (NHP, NDOT and DMV) meet federal requirements and work together more coherently. The second one is for truck parking and is being offered through our freight planning team. They have called permits into the committee and we are thankful for the opportunity to help and have our voice heard.

Nevada

- Communication efforts: This year has been an adventure in Nevada. We've been dealing with major flooding and the closure of many of our main routes. As a team, we have kept track of closures and automatically rerouted loads to get them through our state.
- Special challenges: Our biggest challenge is construction. When the roads are closed to 12' wide and it is a major artery we run into issues (I-80)
- Successes: This year we were recognized by our governor for helping the mobile home industry. We had several loads (225) that needed to get through construction and with communication between our RE and myself we could come up with a schedule for the movement.

New Legislation:

- Annual overlength permit up to 120' long \$150 per calendar year.
- Annual over width changed to \$150 per calendar year
- Permitting up to 129,000 GVW for divisible loads on selected roadways. US 2 Statewide, US 52 Saskatchew border to Minot, US 85 South Dakota border to junction of US 2, US 83 from South Dakota Border to Sterling/I-94 junction, US 83 Bismarck to Minot. \$30 single trip, \$100 30 days or \$700 for calendar year.
- 10% overweight permits changed from field to first point of storage now also allowing from first point of storage to first point of sale or change of possession.
- Service fee wording change that allows the Highway Patrol to charge up to \$15 per routed permit. The Patrol changed the price to \$10 per routed permit.

System Updates:

- Industry asked to be able to add trailers and attachments to profile this was completed in May
- Option to just add or delete a lift axle if copying a permit.
- Fixed a system error that would default to 0 in vehicle configurations in the profile.
- New reporting system for industry to pull permit info.
- Currently working to get Google Maps to overlay our permit system.
- Procedural Changes: Two new permits that have been added in our state.
- Innovative or Special Initiatives: Working with routing service provider for an app for drivers to get turn my turn directions. Hoping to eliminate some bridge hits if they use this function for vehicles that are off route.

- Communication Efforts: Work with NDMCA, AGC, ND Petroleum Council, ND Implement Dealers Association & SC&RA to get information out to industry. We do several training classes on the permit system each year though-out the state. We place a system notifications box on our E-permits that appears when you log in if we need to get information out to industry. We use Facebook, our NDHP webpage and the NDDOT Travel information map posting for road closures, no travel advised, no oversize loads, etc.
- Special Challenges: Lack of time with state IT to make more improvements on our computer system.
- Uniformity Pursuits: Working on the 129,000 permits. Coming up with ways to get roads added. Congressman Cramer has approval for I-94 & I-29 on the US House side, We are waiting on the Senate side. Senator Hoeven is working on this issue for the Senate side. Once we get interstate approved we will have better connectivity.
- Areas of Concern: Statewide budget cuts trying to do more with less. Still needed to update infrastructure with less dollars to spend. Stopping bridge hits.
