- Rebecca Dick, Arizona DOT-New Partnering Facilitator with ADOT. Welcome Rebecca!
- ➤ Jon Keeth, Washington DOT-WADOT award application deadline is today. WADOT has vaccination mandates. WADOT Partnering Steering Committee has asked for metrics to measure the effectiveness of partnering programs/meetings. We have a pretty good prequal process that's tied to prime contractor performance reports.
- > Jace Mecham, Utah DOT- Currently rebranding their Partnering Program.
- Duane Milligan, Texas DOT-Partnering award program "We Build Texas" award.
- ➤ Jake Goettle, Montana DOT- Partnering within the construction division ongoing for 3 years with training required for MDOT and contractors. MDOT currently has a Partnering Program Manager position available if you know of anyone wanting to relocate to beautiful Montana.
- ➤ Jerry Valdez, New Mexico DOT- NMDOT has been working on establishing a Partnering Contractor program for the past year. The NMDOT has worked with the AGC to gain contractor buy-in to the program. This would add Partnering as a prequalification when bidding on projects. We are implementing a contractor pre-qualification that looks at claims, etc. *

*Most states use the low-bid approach to awarding construction projects with no prequalifications identified (except alternative delivery projects).

What can we contribute to improving the Partnering resources for WASHTO states?

Community of Practice ACTION ITEMS:

- Research and gather metrics used to measure the effectiveness of partnering.
- ➤ Reach out to other divisions within your agency who collect data on construction projects(Finance, Field Reports, Risk, etc.).
- Suggested items to research include:
 - → Quantitative vs. Qualitative data
 - → Projects that finish on or ahead of schedule
 - → Projects that are within or under budget
 - → Number of escalations above the field level (RE, DE, SEO)
 - → Project team survey/close out reporting
 - → Other cost savings related to projects attributable to partnering
 - → Formal Partnering vs. informal/No partnering project success
 - → Safety incidents on partnered projects vs. non-partnered projects
 - → Customer satisfaction of final product (owner, contractor and public)
- ➤ **Jerry V**.- Check with Tisha C. as to how the Construction & Materials Subcommittee would like us to communicate with them.
- > Mrudang S. Working on quantifying "man hours saved" (RE/PM cost savings) linked to partnering efforts.
- ➤ **Nichole J.** will research Michigan State studies related to partnering and share any findings at the January 2022 meeting.
- Provide your findings in an email and I will put them together in a report to share, review and compare at the January meeting.
